Sealed percentage rate Tenders in B-I forms are invited by the Divisional Engineer, M.S.R.T.C. Aurangabad from Registered in appropriate Class and Unregistered but experienced Civil Contractors for the following works.

The Contractors will have to submit the following credentials / documents for obtaining the tender form :-

1. Latest Registration Certificate in case of registered contractor.
2. Audited Balance Sheet with Profit and Loss Account, issued by Chartered Accountant in respect of contractors having Annual Turn-over of more than Rs. 40 Lacs.
3. The statement of total Income contract Receipt in prescribed proforma of Income Tax Department, dully certified by Chartered Accountant in respect of Contractors having Annual Turn-over of less than Rs. 40 Lacs.
4. Acknowledgement of Income Tax Return filed to be submitted.
5. Solvency Certificate to the extent of 20% of the estimated cost of the work issued by Scheduled Bank or revenue authority on immovable property.
6. Details of similar works executed during last 3 years out of which one work at least to the extent of amount of work concerned along with Certificate from concerned Department.
7. Details of similar works in hand at present out of which one work at least to the extent of works concerned along with Certificate from the concerned Department.
8. "Partnership Deed" & "Power of Attorney" in case of contractor having partnership firm.
9. List of Machinery, Tools & Plants, Equipment owned by the, Contractor & having guniting machinery is only allowed to participate in tender.
10. Sales Tax registration and latest clearance certificate. '

THE AGENCY SHOULD NOTE:-

1. Rates quoted by the contractors will remain valid for 120 (One Hundred Twenty Only) days only from the date of opening of tenders.
2. Right to reject any or all tenders, without assigning any reason, is reserved.
3. Conditional tender is liable to be rejected and the E.M.D. paid by the contractor will stand forfeited.

4. The contractors should quote their offer in words & in figures, in ink only, either in Marathi or Hindi or English.

5. No postal transaction will be entertained.

6. Valid certificate of Registration under contract Labour Act (R & A Act 1979) before starting the work after acceptance of tender shall have to be submitted.

7. Rates quoted by the contractors shall be inclusive of all Central & State Govt. Taxes, all Local Taxes, Royalty, Octroi and also Turn - Over Tax and these taxes are not refundable.

8. Detailed Plans, estimate, tender conditions, specifications etc. are available for guidance of contractors in the office of the Divisional Engineer, M.S.R.T. Corporation Aurangabad on all working days, during office hours.




