MSRTC invites tender for procurement of city ready built Semi Low Floor buses under JnNURM Scheme from the buses / chassis manufacturers only as per the specifications recommended by Ministry of Urban Development, Govt. of India with 900 mm floor height and Pre Qualification Criteria for approximate quantity 100 for One Year Contractual Period. Tender will be in two Bid System comprising of "Qualification Criteria with Technical Tender" and "Commercial Tender". Tender should be deposited in this office upto 14.00 hours on 25.11.2009. Tenders received late will not be accepted. Value of tender form is Rs. 16,875.00 including Sales Tax / VAT. The parties applying for tender form should produce letter conforming that, they are chassis / vehicle manufacturers. No tender form will be issued in absence of such certificate. The last date for issue of tender form is 25.11.09 upto 13.00 hrs.

The specification, description and conditions are given in tender form. Only authorized person will be allowed to attend the tender. There will be Pre Bid Conference tentatively on 19.11.2009 at 11.30 hrs. in the chamber of VC & MD.

Holidays (4) tender will be outrightly rejected if Tenderers those do not accept standard terms and conditions of the tender.
