Fund Accounts, Mumbai-400008, payable at Mumbai only, along with manufacturer's authority letter. 4) Tender form will be issued between 10.30 A.M. to 1.00 P.M. and 1.30 P.M. to 3.30 P.M. on any working day(Except 2<sup>nd</sup> &4<sup>th</sup> Saturday &Sunday).5) Payment Term is "100% payment after 30 days on receipt & acceptance of the material only. Any payment term other than this will not be accepted. 6) Earnest Money Deposit should be 1% of the tender value subject to the minimum of Rs.5000/- and maximum of Rs.1,00,000/- for each tender to be paid in cash or by D.D. as mentioned in Tender Form, before opening of tender.7) The representative attending tender opening must produce authority letter without which he/she will not be allowed to attend the meeting. 8) Selection of Sources will be finalized for a item as per last Column. 9)The merit for selection of sources will be competitive rates and better terms & conditions offered in tender, quality of material & as per formula decided by Corporation.10) Acceptable L-2, L-3 Tenderer have to match their rates with L1(1st-Lowest) rates. 11) Security deposit - Successful Tenderer shall have to pay security deposit equal to 10% amount of business allotted for business upto 300 lakhs & for allotment of business above Rs. 300 lakhs , security deposit will be Rs. 30 lakh + 1 % of business allotted above Rs.300 lakhs. The Security Deposit is to be paid in cash or in form of B.G. from Nationalized Bank/Scheduled Bank on Stamp Paper of Rs.100/- within 15 days from intimation. 12) Performance Guarantee – The successful bidder has to pay the performance guarantee equal to 5 % of the business allotted for items i.e Tyre retreading material, Spring Assys & leaves, Machinery & office equipments etc. in cash or in form of B.G. from Nationalized Bank/Scheduled Bank on Stamp Paper of Rs.100/- within 15 days from intimation. 13) If successful Tenderer fails to supply the material, his EMD/SD will be forfeited.
