MSRTC invites tender for the supply of bus chassis from manufacturer only for approx. quantity 2300  $\pm$  10% nos. for one year suitable for Ordinary, Semi Luxury buses, as per MSRTC specification and pre-qualification criteria. The tenders will be in two bid system comprising of "Qualification Criteria with Technical Tender" and "Commercial Tender". The tender should be posted / deposited so as to reach this office before 14.00 hours on 18.2.2008. Late received tender will not accepted. Value of tender form is Rs.5000.00 exclusive of Sales Tax / VAT. The parties applying for Tender Form should produce letter confirming that they are manufacturers. No Tender Form will be issued in absence of such certificate. The last date for issue of tender form is 18.2.2008 upto 13.00 hours.

The specification, description and conditions are given in Tender Form.

Only authorized person will be allowed to attend the tender. There will be Pre Bid Conference tentatively on 11.2.2008 at 11.30 hours in the chamber of Vice Chairman & Managing Director .

N.B. (1) Technical tender will be opened on 18.2.2008 at 15.30 hours and commercial tender will be opened on 20.2.2008 at 15.30 hrs. (2) Tender forms can be obtained from this office on payment in cash or DD in the name of MSRTC Fund Accounts, Mumbai 400 008, payable at Mumbai only alongwith manufacturers certificate / authority letter. Money Order will not be accepted. (3) Tender form will be issued between 10.30 hours to 13.00 hours and 13.30 to 14.30 hours on any working day except 2<sup>nd</sup> & 4<sup>th</sup> Saturday, all Sundays and Govt. holidays (4) Tender will be out-rightly rejected if Tenderers those do not accept standard terms and conditions of the tender. (5) An EMD will be Rs. 20,00,000 (Rupees Twenty Lakhs Only) for each tender to be paid by DD / Bank Guarantee before opening tender.
